Your institution is bound by the rules of admission, reservation, tuition fees and other fees as prescribed by the Government of Maharashtra, Directorate of Technical Education, State of Maharashtra, Mumbai Fees Regulating Authority, Mumbai Admission Regulating Authority, Mumbai, All India Technical Education Council, New Delhi and Pharmacy Council of India, New Delhi from time to time. It will be mandatory to follow the decision in this regard.
6. A proposal should be submitted to the Fees Regulating Authority Bandra to decide the fees of your institution. The fee for the said course should be charged as approved by the Fees Regulating Authority. No fee should be charged in excess of the prescribed tuition fee. 8. The Director or his representative shall have the right to make unannounced visit to the institute at any time to inspect the availability of space, building, teaching and non-teaching staff and other facilities as per All India Council of Technical Education/Government standards.
